Notice is hereby given that the Board of Com-
missioners of Porter County, Indiana will re-
ceive sealed bids until 4:30 P.M. CST, Monday,
March 13th, 2017 at the office of the Porter
County Auditor, 155 Indiana Ave., Suite 204,
Valparaiso, Indiana. Bids will be opened by the
Porter County Board of Commissioners on
Tuesday, March 14th 2017 at 10:00 A.M. DST,
Porter County Administration Center, 155 Indi-
ana Ave., Valparaiso, Indiana 46383. The fol-
lowing items will be available for use at all Por-
ter County Government facilities and structures,
both existing and future:

3. Bituminous Plant Mix

Specifications may be obtained at the Porter
County Highway Dept., 1955 S. State Road 2,
Valparaiso, IN 46385.

Each item bid shall be submitted in a separate
envelope with bid class and bid number speci-
fied. Each item shall be on an individual official
form No. 95 approved by the State Board of Ac-
counts and accompanied by a Non-Collusion
Affidavit.

Each bidder shall accompany his bid with a bid-
der's bond or certified check payable to the Por-
ter County Treasurer for each item bid when-
ever the total of such bid is in excess of One
Thousand Dollars (\$1,000.00) and said bond
check shall not be more than ten (10) percent of
the total bid. The surety on any bond must be
acceptable to the Board of Commissioners. If
there is no total specified on the bid, the mini-
mum bond or certified check of One Thousand
Dollars (\$1,000.00) will be required for each
item bid.

The Board of Commissioners reserves the right
to reject any and all bids or parts thereof, waive
all informalities, or irregularities in bidding and
to re-advertise.

The Porter County Board of Commissioners will
utilize evaluation criteria set forth in the bid pur-
suant to IC 5-22-7-2 and the bid shall be
awarded to the lowest bidder responsible and
responsive bidder pursuant to IC 5-22-7-8.
However the Porter County Board of Commis-
sioners will utilize IC 5-22-15-20-9 when evalu-
ating the bids.
