**PROJECT** - This project generally consists of asphalt and concrete pavement improvements at three (3) school locations in the Duneland School Corporation system. Pavement improvements include full depth asphalt removal and reconstruction of existing parking surfaces, re-striping, construction of new asphalt drive-ways and pavement, and other general pavement related improvements as necessary.

**BID REJECTION** - The OWNER reserves the right to reject any and all bids, waive any informalities in bidding or to accept the bid or bids which best serves the interests of the Duneland School Corporation.

**WITHDRAWAL OF BIDS** - No bid shall be withdrawn for a period of 60-days after the scheduled opening without the consent of the OWNER.
