PROJECT This project generally consists of asphalt and concrete pavement improvements at six (6) school locations in the Duneland School Corporation system. Pavement improvements include the milling, resurfacing of existing asphalt driveways, crack remediation, seal coating, and re-striping of existing asphalt parking and driveways; new asphalt and concrete pavement supplement to parking areas and driveways; replacement and widening of concrete sidewalks, and other general pavement related improvements, including minor drainage system improvements as necessary.

TIME Sealed bids will be received until 2:00 pm local time, on Thursday, April 28, 2016 in the Duneland School Corporation Administration Center, 601 West Morgan Ave., Chesterton, IN 46304. Bids will be publicly opened and read aloud at that time.

BIDS All bids shall be addressed to Duneland School Corporation C/O Mr. Greg Lindy, Director of Support Services, 601 West Morgan Ave., Chesterton, IN 46304.

Bids shall be sealed and shall have the name and address of the bidder and the contract for which the bid is being submitted on the outside of the envelope. All bidders shall bid in accordance with and upon the Bid Forms included in the contract documents.

BID SECURITY No bid shall be received unless accompanied by a certified check or satisfactory bid bond payable to Duneland School Corporation in the in an amount not less than 5 % of the maximum bid as a guarantee that, if the bid is accepted, the bidder will execute and file the contract, performance/payment bonds and insurance certification, as required by the contract documents, within ten (10) days after the Notice of Award.

BID REJECTION The OWNER reserves the right to reject any and all bids, waive any formalities in bidding or to accept the bid or bids which best serves the interests of the Duneland School Corporation.

WITHDRAWAL OF BIDS No bid shall be withdrawn for a period of 60-days after the scheduled opening without the consent of the OWNER.

GOVERNING LAWS & REGULATIONS The contract letting shall be subject to and governed by the laws of the State of Indiana.

WAGE RATE DETERMINATIONS - The CONTRACTOR shall be required to pay not less than the wage rates established for the project by the General Assembly of Indiana. Copies of these wage rates are on file with the OWNER and incorporated in the contract documents.
