

NOTICE TO BIDDERS

Notice is hereby given that the Town of Beverly Shores, Indiana will receive sealed bids for the following:

CALENDAR YEAR 2018 STREET POTHOLE PATCHING, PAVING, CULVERT REPAIR/REPLACEMENT, STRIPING, AND SWEEPING; CALENDAR YEAR 2018 MOWING AND BRUSH REMOVAL STREET SHOULDER RIGHTS OF WAY; SPRING 2018 THROUGH WINTER 2018 TREE AND DEBRIS REMOVAL FROM STREETS AND RIGHTS OF WAY; SNOW REMOVAL.

A bidder may bid on all or any portion of the work. The specifications for the work may be obtained from the Beverly Shores' Street Commissioner Marshal Susan H. Resteau at the Administration Building located at 500 S. Broadway, Beverly Shores, IN 46301 (Marshal's Office) Telephone Number 219-879-8800.

Bids shall be submitted to the Beverly Shores' Clerk-Treasurer office. The bids will be opened at the Beverly Shores Town Council Meeting, which begins at 7:00 P.M. CDT, on May 15, 2018 at 500 Broadway, Beverly Shores, IN 46301.

All submissions shall contain an Indiana statutory Form 96, including, without limitation, financial statement, non-collusion affidavit, and certification of non-segregated facilities of the bidder.

Each bidder must comply with IC 22-5-1.7 et seq. and participate in the E-Verify Program and execute an affidavit of compliance. Each bidder must ensure that all employees and applicants for employment are not discriminated against because of race, creed, color, sex, sexual orientation, disability or national origin.

No bidder may withdraw a bid within a period of 60 days following the date set for receiving bids. A certificate of insurance naming the Town of Beverly Shores as an additional insured shall be required from all contractors who are awarded a proposal before they can commence work and must contain the minimum acceptable insurance limits of \$250,000 property damage, \$750,000 per person for bodily injury or death with a combined single limit of \$1,000,000 per occurrence. The Town of Beverly Shores reserves the right to waive any formality, informality, or irregularity in any proposal received, and also reserves the right to reject any and all proposals and to re-advertise for proposals.
