A. Notice is hereby given that the Board of Commissioners of Porter County, Indiana, hereinafter referred to as the OWNER, will receive sealed bids for the following project:

Proposals may be forwarded individually by registered mail or delivered in person, addressed to the Auditor of Porter County - Vicki Urbanik, 155 Indiana Ave. Suite 204, Valparaiso, Indiana, 46383, prior to 4:00 p.m. (CST) Monday, August 14, 2017. Bids received after the 4:00 p.m. (CST) deadline will not be considered, and will be returned to the bidder unopened.

D. All proposals will be considered by the OWNER at a public meeting held in the Porter County Administration Building, Commissioner's Chambers of Porter County, Indiana located at 155 Indiana Ave. Suite 204, Valparaiso, IN 46383 and opened and read aloud at 10:00 p.m. local time, Tuesday, August 15, 2017.

E. The work to be performed and the proposals to be submitted shall include a bid for all general construction, labor, material, tools, equipment, taxes (both federal and state), permits, licenses, insurance, service costs, etc. incidental to and required for this project.

F. This project will be subject to the Porter County Municipal Code, local hiring and the equal employment opportunity programs.

G. All materials furnished and labor performed incidental to and required by the proper and satisfactory execution of the contract to be made, shall be furnished and performed in accordance with requirements from the contract documents.

H. Contract Documents will be on file at Porter County Administration Building, Auditor's Office, at 12:00 p.m. (CST) on July 19, 2017. Construction Documents may be purchased on Compact Disc from the Auditor's Office for a sum of \$50.00 each. Bidders desiring printed documents shall pay for the cost of printing, shipping and handling.

I. Each individual proposal must be enclosed in a sealed envelope bearing the title of the project and the name and address of the bidder on the front of the envelope. All mailer packets shall have a separately sealed envelope inside the mailer. Bids may be submitted until the listed time and date and bear the following:

K. Each proposal must be submitted separately. The bidder shall affix identifying tabs to the following sheets of each proposal:

4. Financial Statement

5. Receipt of Addendum (If Applicable)

L. Each individual proposal shall be accompanied by a Bid Bond and completed AIA Document A310-2010, Bid Bond. The Bid Bond shall be a certified check or acceptable bidder's bond, made payable to the Auditor of Porter County in the sum of no less than five percent (5%) of the bid amount; the check or bond will be held by the said Auditor of Porter County as evidence that the bidder will, if awarded a contract, enter into the same with the OWNER upon notification from him to do so within fifteen (15) days of said notification. Failure to execute the contract and to furnish performance and payment bonds to the Auditor of Porter County will be cause for forfeiture of the amount of money represented by the certified check, or bidder's bond, as and for liquidated damages. Form 96, as prescribed by the Indiana State Board of Accounts, shall be properly completed, and submitted with the bid proposals. The Board of Works, at their discretion reserves the
