Jefferson St., Valparaiso, Indiana, 46383 until 4:00 PM on September 13, 2019, at which time they will be opened and publicly read aloud. Bids received after the above stated time and date as specified, shall be returned to the sender unopened and declared non-acceptable.

All Bidders are requested to attend the Pre-Bid Meeting. The Pre-Bid Meeting will begin at 1:00 PM on September 5, 2019 at the Hebron Branch Library Meeting Room at 201 W. Sigler St., Hebron, Indiana, 46341 and will then move to the Kouts Public Library at 101 E. Daumer Rd., Kouts, Indiana, 46347 and then will move to the Valparaiso Public Library at 103 W. Jefferson St., Valparaiso, Indiana, 46383 and then will move to the South Haven Public Library at 403 W. 700 N., Valparaiso, Indiana, 46385 and then will move to the Portage Public Library at 2665 Irving St., Portage, Indiana, 46368.

Work includes: Asphalt Paving, Concrete Walks & Curbs and Flooring.

Separate Prime bids will be received per the Bid Form for:

- Paving, Concrete Walks and Curbs
- Flooring

All Bidders must submit a satisfactory bid bond executed by the bidder and surety company or a certified check or bank draft, payable to the Porter County Public Library in an amount equal to five percent (5%) of their maximum bid, as provided by law.

The successful Bidder, within ten (10) days of acceptance of bids, will be required to execute a performance bond requiring one hundred percent (100%) performance and one hundred percent (100%) labor and material payment. In the event of failure of the successful bidder to execute said bond as stated above, the bidder shall forfeit its bid guaranty as liquidated damages, Bid guaranties of unsuccessful bidders shall be returned upon award of contracts.

Bid Documents will be available in PDF format from the Architect at no cost upon request. Bid Documents are also available for review at the Architect's Office and at the Porter County Public Library Administrative Office at 103 W. Jefferson St., Valparaiso, Indiana.

All bids shall be sealed and submitted on the Bid Proposal Form in the Project Manual obtained from the office of CSK Architects, P.C., 6919 W. Lincoln Highway, Crown Point, 46307. Bids shall be properly executed on Form 96 including the Non-collusion Affidavit and Contractor's Financial Statement, as prescribed by the Indiana State Board of Accounts and all other Bid Documents requested.

Bidders shall submit to the Architect within 24 hours from bid due date and time a complete list of all sub-contractors to be awarded contracts on this project. Bidder's bid may be rejected if the sub-contractors list is not submitted as requested. The successful bidder's award of sub-contractors contracts shall not deviate from the sub-contractors list as submitted unless approved by the Owner.

The Porter County Public Library reserves the right to reject any or all bids, to waive any informalities in bidding, or to return unopened any proposal received after the time fixed herein.

No Base Bid or Alternates shall be withdrawn for a period of sixty (60) days, subsequent to the opening of bids.
