

ORDINANCE NO. 2016 -11
AN ORDINANCE OF THE
CHESTERTON TOWN COUNCIL
AMENDING THE TOWN CODE

WHEREAS, Ordinance No. 2015-09, "Amendment to Ordinance 2002-15 An Ordinance of the Town of Chesterton, Porter County, Indiana, Amending a Planned Unit Development District Second Addition to Coffee Creek Center Planned Unit Development at Morgan's Corner," expressly prohibited parking in certain areas of the Morgan's Corner Planned Unit Development (2015-09, at § 14(m)), and reserved the right for the Town Council to restrict parking to one side of the street in all other areas (2015-09, at § 14(n));

WHEREAS, the regulations in this Ordinance have been forwarded with the unanimous recommendation of the Town of Chesterton Board of Metropolitan Police Commissioners; and

WHEREAS, the Chesterton Town Council agrees with the unanimous recommendation of the Police Commissioners.

NOW THEREFORE, BE IT AND IT IS HEREBY ORDAINED by the Chesterton Town Council as follows:

SECTION ONE. "Sec. 13-54 prohibited parking areas" of the Chesterton Town Code, shall be amended by the addition of a subsections "X" - "GG" which shall read as follows:

X. No vehicle shall be parked for a distance of forty feet (40') from the curb return tangent of Bostwick Avenue, Cole Street, Delos Marr Avenue, Dunbar Street, Gossett Mill Avenue, Gustafson Avenue, Hickory Grove Street, Harrington Avenue, Murray Street, and Rosenquist Street.

Y. No vehicle shall be parked along the center island curb of Dunbar Street, in the circle drive intersecting Dunbar Street, Delos Marr Avenue, and Gossett Mill Avenue.

Z. No vehicle shall be parked along the center median curb on Dunbar Street between County Road 1050 N and Delos Marr Avenue.

AA. No vehicle shall be parked on the east side of Cole Street.

BB. No vehicle shall be parked along the center curb of the triangular intersection of Bostwick Avenue and Delos Marr Avenue.

CC. No vehicle shall be parked on the south side of Gossett Mill Avenue between Dickinson Road and Dunbar Street.

DD. No vehicle shall be parked on the north side of Gustafson Avenue between Dickinson Road and Dunbar Street.

EE. No vehicle shall be parked on the north side of Gustafson Avenue between Dunbar Street and Hickory Grove Street.

FF. No vehicle shall be parked on the west side of Dunbar Street, or on the south side of Harrington Avenue within the intersection of Dunbar Street and Harrington Avenue.

GG. No vehicle shall be parked along the center island curb on Murray Street between Delos Marr Avenue and Gossett Mill Avenue.

SECTION TWO. The Chesterton Street Commissioner shall be responsible for placing and maintaining appropriate signage and street markings in this area.

SECTION THREE. Any violation of these parking restrictions shall subject the offender to the penalty provisions of Sec. 13-55, Sec. 13-75, and Sec. 1-9 of the Chesterton Town Code.

SECTION FOUR. This ordinance shall be in full force and effect from and after its adoption and publication as required by law.
