NOW THEREFORE BE IT AND IT IS HEREBY ORDAINED THAT:

County Municipal Code is hereby amended through the addition of Chapter 3.72 entitled Ordinance Establishing Memorial Opera House ARTS MIDWEST TOURING FUND Grant Fund.
2. That Section 3.72.010 is added to the Porter

County Municipal Code to read as follows: 3.72.010 Fund Established

The Board of Commissioners have determined that a need exists for the creation of a fund for deposit of grant funds for the Porter County Me-

morial Opera House. 3. That Section 3.72.020 Use of Revenue is added to the Porter County Municipal Code to read as follows: 3.72.020 Use of Revenue

The funds received and deposited in the Memorial Opera House ARTS MIDWEST TOURING FUND Grant Fund can be used only for the specific purposes set forth in this chapter. The specific purposes set form in this original funds received and deposited in the Memorial ARTS MIDWEST TOURING ARTS MIDWEST

Opera House ARTS MIDWEST TOURING FUND Grant Fund shall be expended exclusively for the expenses related to the Porter County Memorial Opera House as approved. The funds deposited in the Memorial Opera House ARTS MIDWEST TOURING FUND

Grant Fund are subject to appropriation by the Porter County Council.

4. That Section 3.72.030 Termination of Fund,

Transfer of Funds is added to the Porter County Municipal Code to read as follows:

Termination of Funds, Transfer of 3.72.030 Funds

The Memorial Opera House ARTS MIDWEST TOURING FUND Grant Fund is a non-reverting

fund and shall remain in existence and remain perpetual in its terms until amended or termi-

nated by subsequent ordinance enacted by the Porter County Board of Commissioners. If and when a subsequent ordinance is passed to ter-

minate the life of this fund, the balance existing, if not otherwise provided for by ordinance shall revert to the Porter County General Fund.
