2020 RADIO SYSTEM PROJECT

PROJECT: Duneland School Corporation (DSC) is accepting bids for a new digital two way radio solution (300 radios and 10 UHF repeaters) that has the ability to communicate over a network connection (IP) to all sites. Vendor must be located within a 50 mile radius from DSC. DSC is accepting bids for both Motorola (preferred) and Hytera (acceptable alternate) manufacturers. Portable radios requested: Motorola XPR-3500 and/or Hytera PD5621-U1 (separate bids for each manufacturer) with a 5 year warranty provided on radios and a three year warranty on the battery. TIME: Sealed bids will be received until 1:00pm (local time) on Thursday, November 19, 2020 in the Duneland School Corporation Administration Center, 601 W. Morgan Ave., Chesterton, IN 46304. Bids will be opened and publicly read aloud at that time. Bids received after the deadline will not be accepted or opened. BIDS: All bids shall be addressed to Duneland School Corporation, C/O Mr. Robert McDermott, Assistant Superintendent, 601 W. Morgan Ave., Chesterton, IN 46304 and clearly marked on the outside of the envelope: ATTENTION: 2020 RADIO SYSTEM PROJECT. Bids shall be enclosed in a sealed envelope and shall have the name and address of the bidder legibly written on the outside of the envelope. All bidders shall bid using the bid forms included in the bid documents.
