Bids will be opened and publicly read aloud at that time. Bids received after the deadline will not be accepted or opened.

Bids shall be sealed and shall have the name and address of the bidder and the contract for which the bid is being submitted on the outside of the envelope. All bidders shall bid in accordance with and upon the Bid Forms included in the contract documents.

**BID SECURITY** - No bid shall be received unless accompanied by a certified check or satisfactory bid bond payable to Duneland School Corporation in the in an amount not less than 5 % of the maximum bid as a guarantee that, if the bid is accepted, the bidder will execute and file the contract, performance/payment bonds and insurance certification, as required by the contract documents, within ten (10) days after the Notice of Award.

**BID REJECTION** - The OWNER reserves the right to reject any and all bids, waive any formalities in bidding or to accept the bid or bids which best serves the interests of the Duneland School Corporation.

**WITHDRAWAL OF BIDS** - No bid shall be withdrawn for a period of 60-days after the scheduled opening without the consent of the OWNER.
