FOR PUBLIC COMMENT
Preliminary Findings Regarding a
Significant Modification to a
Part 70 Operating Permit
for Fritz Enterprises, Inc. in Porter County
Significant Permit Modification No.
127-32319-00123

The Indiana Department of Environmental Management (IDEM) has received an application from Fritz Enterprises, Inc. located at 250 West Highway 12, Burns Harbor, Indiana for a significant modification of its Part 70 Operating Permit (T127-30717-00123) issued on October 12, 2011. If approved by IDEM's Office of Air Quality (OAQ), this proposed modification would allow Fritz Enterprises, Inc. to make certain changes at its existing source. Fritz Enterprises, Inc. has applied to construct one (1) iron pig casting machine.

The applicant intends to construct new equipment that will emit air pollutants; therefore, the permit contains new or different permit conditions. In addition, some conditions from previously issued permits/approvals have been corrected, changed or removed. These corrections, changes, and removals may include Title I changes (e.g. changes that add or modify synthetic minor emission limits). IDEM has reviewed this application, and has developed preliminary findings, consisting of a draft permit and several supporting documents, that would allow the applicant to make this change.

How can you participate in this process?

The date that this notice is published in a newspaper marks the beginning of a 30-day public comment period. If the 30th day of the comment period falls on a day when IDEM offices are closed for business, all comments must be postmarked or delivered in person on the next business day that IDEM is open. You may request that IDEM hold a public hearing about this draft permit. If adverse comments concerning the air pollution impact of this draft permit are received, with a request for a public hearing, IDEM decide whether or not to hold a public hearing. IDEM could also decide to hold a public meeting instead of, or in addition to, a public hearing. If a public hearing or meeting is held, IDEM will make a separate announcement of the date, time, and location of that hearing or meeting. a hearing, you would have an opportunity to submit written comments and make verbal comments. At a meeting, you would have an opportunity to submit written comments, ask questions, and discuss any air pollution concerns with IDEM staff.

What will happen after IDEM makes a decision? Following the end of the public comment period, IDEM will issue a Notice of Decision stating whether the permit has been issued or denied. If the permit is issued, it may be different than the draft permit because of comments that were received during the public comment period. If comments are received during the public notice period, the final decision will include a document that summarizes the comments and IDEM's response to those comments. If you have submitted comments or have asked to be added to the mailing list, you will receive a Notice of the Decision. The notice will provide details on how you may appeal IDEM's decision, if you disagree with that decision. The final decision will also be available on the Internet at the address indicated above, at the local library indicated above, and the IDEM public files room on the 12th floor of the Indiana Government Center North, 100 N. Senate Avenue, Indianapolis, Indiana 46204-2251 and IDEM Northwest Regional Office, 8380 Louisiana Street, Merrillville, IN 46410.
