

NOTICE TO BIDDERS

(Advertisement for Bids)

Sealed bids will be received by the Town of Porter, attention Clerk-Treasurer, 303 Franklin Street, Porter, Indiana 46304 until 3:00pm CST Tuesday April 23, 2013 and immediately thereafter will be publicly opened and read aloud to furnish and install hot asphalt concrete pavement on certain designated streets within the Town. Any bids received later than the above time will be returned unopened.

DESCRIPTION OF WORK: Furnish and install 10,000 tons, more or less, of hot asphalt concrete pavement, including tack coat, binder and surface courses, on certain designated streets within the Town of Porter. Streets shall be determined by the Town of Porter. Provide a Unit Price per Ton to furnish and install hot asphalt concrete binder and surface courses. Provide a Unit Price per Gallon to furnish and apply tack coat. Provide a Unit Cost per Cubic Yard for milling approximately 24,000 cubic yards of asphalt from certain designated streets within the Town of Porter boundaries. Streets shall be determined by the Town of Porter. Millings shall be delivered by the contractor to Porter Street Department at 550 Beam Street, Porter, IN 46304. Roads that are milled shall be swept by Contractor. Roads that have milled tie-in joints shall be cleaned by Contractor.

All work shall be in accordance with Town Standards and Indiana Department of Transportation (INDOT) Specifications, latest editions. In the event of a conflict, the most restrictive requirements shall apply.

Contractor and all Subcontractors shall be licensed with the Town of Porter Building Department. Contact the Town of Porter Building Department at (219) 395-9921 or visit the Town website at www.townofporter.com for license application and other information.

All bids shall be on a State of Indiana approved form and accompanied by an E-Verify Affidavit and a Certification Regarding Investment Activities in Iran.

INDIANA REQUIREMENT: Standard Indiana Form 96 (Revised 2009) which includes non-collusion affidavit will be required.

BID SECURITY: Each bid shall be accompanied by an acceptable certified check or cashier's check made payable to the Town of Porter or an acceptable Bid Bond in an amount not less than five percent (5%) of the total bid price executed by an incorporated surety company in good standing and qualified to do business in the State of Indiana.

BONDS: A performance bond and payment bond, in a form acceptable to the Town Council, each in the amount of one hundred percent (100%) of the contract price will be required.

No bidder may withdraw his proposal for a period of 60 days following the date set for receiving bids. The Town of Porter reserves the right to retain any and all bids for a period of not more than 60 days, and said bids shall remain in full force and effect during said time. The Town of Porter further reserves the right to waive informalities and to award the contract to any Bidder all to the advantage of the Town of Porter or to reject all bids.
